1. You will be engaged as **Trainee - Screener** from 12th May 2022 to 11th May 2023 at Mumbai International Airport Limited.
2. General Guidelines: Working hours – 9.00 am to 5.30 pm ; Weekly off - All Sundays and 2nd and 4th Saturdays ; Leaves – 2 days per month
3. You will be required to maintain a learning diary and will go through quarterly review which could include assessment in form of written test and interview.
4. You will be required to undergo Basic AVSEC and ILBHS classroom trainings, On job trainings and certification exams during the 12-month training period.
5. Safety, Security rules and protocols with all precautions must be followed and Mumbai International Airport Limited is no way responsible for any accidents or unforeseen events during the trainee period.
6. During the trainee period, you should maintain strict discipline at the work premises and not indulge in any activities which are detrimental to the interest of the company.
7. All proprietary information/material of the Mumbai International Airport Limited that is made available to you, shall be received in confidence and shall not be disclosed or used. Trainees agree that all information, correspondence, documents, materials or items provided by Mumbai International Airport Limited are provided to them in trust and on lapse/termination of the trainee period, the trainees shall promptly return all such material to the Mumbai International Airport Limited.
